- Retired Parks and Recreation Professional** **\$30**
 For retired park, recreation and leisure professionals who are no longer associated with an agency or organization. This category has full voting privileges and receives all discounts and publications.
- Volunteer/Affiliate** **\$30**
 For volunteers of agencies and organizations that provide park, recreation and leisure services, or for members of the general public not involved in the profession, with an interest in supporting APRA's mission. This is a non-voting category, but receives all publications.
- Student** **\$15**
 For full-time high school or undergraduate college students. This is a non-voting category, but receives all publications.

- Associate** **\$250**
 For businesses, consultants, vendors, exhibitors, and advertisers that sell products or services to park, recreation and leisure providers. This is a non-voting category, but receives all publications as well as discounts on trade exhibits.
