The following Special Provisions are added to this agreement:

1. The City reserves the right to cancel any event, game, or tournament (collectively "event") that User is scheduled to conduct or participate in at any time should it be deemed that an event does or will not meet any applicable State of Arizona guidelines or orders in accordance with the phasing regulations and orders.
2. User must submit its work plan that it intends to put in place in order to comply with applicable protocols, guidelines, and orders that are consistent with the Center for Disease Control's directives 14 days before their event. City has the right to revise these precautions.
3. The City, in its discretion, has the right to limit the number of fans entering the park as well as the number of games due to the health, safety, and welfare within its facilities, due to all applicable State of Arizona and federal protocols guidelines and orders, and CDC guidance.
4. If User decides to use a third party to perform extra cleaning, User will incur all cost performed by the third party.
5. User must provide staff members to regulate number of event attendees entering the property, as necessary, to promote organized movement and distancing of event attendees.
6. The City of Peoria is not responsible for providing User's staff members or guests with recommended Personal Protection Equipment.
7. Dependent upon the calendar date a USER's event aligns with the designated State of Arizona Re-Opening Phase, or at the City's discretion, the following amenities may or may not be available:
 - 7.1. Dugouts
 - 7.2. Bleachers for non-game participants
 - 7.3. Umpire Rooms
 - 7.4. Public Drinking Fountains
 - 7.5. Concession Stand Food Service
